#### FINANCIAL REPORT

The Escrow account beginning balance was \$39,267.50 but after deposits of \$525.00 and checks in the amount of \$3,565.50 tonight, the ending balance is \$36,227.00. Brenda Davis said the Highway Aide beginning balance was \$215,115.89 but with interest of \$11.23, the ending balance is \$215,127.12. Ms. Davis stated the Act 13 Impact Fee fund beginning balance is \$259,064.56 but with interest of \$21.29, the ending balance is \$259,085.85. Steinheiser motioned to accept the financial report and pay the bills. Longdon, seconded. Roll call, yes.

Brenda Davis stated the Act 13 impact fees in the amount of \$174,573.37 are to be received by July 1, 2014.

#### **NEW BUSINESS**

Steve Soley requested a 10 ft. front setback modification to build a garage. He showed a diagram and explained that his property is on a curve and needs this modification. After board discussion, Steinheiser motioned to grant Mr. Soley a 10 ft. front setback modification. Kroll, seconded. Roll call, yes.

Don Reedy is requesting to build a replacement garage that will only hold his personal equipment, nothing for his commercial business which is on this parcel and wanted to know if he can build through Ag Security procedures or residential? The board told him to check at Township tomorrow to see if this parcel is in Ag Security and if it is then the replacement garage can be built under Ag Security provisions.

### **REQUEST TO BE HEARD** - three minute limit

Doug Johnston was present to ask the current status of a swimming pool at 407 Fawn Drive that was to be removed by May 31st but still remains. The brother of Darnell Martin, who owns the pool, started to speak but was told he could not because he was not on the agenda. Mr. Menchyk, Jr. stated the pool should have been removed by May 31, 2014. Steinheiser stated Ms. Martin has had ample time to remove the pool. Ms. Martin stated it is unreasonable to request her to take down the pool. She stated she may have not followed the proper procedure because she didn't know she needed a permit but she pays her taxes and stated other Woodlands residents have closer structures to the road than she does. The board told her if a written complaint comes in on them then the board will investigate, however you are still in violation. Mr. Steinheier stated the pool will either have to be moved within setbacks after obtaining a permit or be removed. The board agreed.

### **PLANS**

Steinheiser stated Butler Sports Arena granted the Township a 90 day extension to review their plan.

#### **ENGINEER REPORT**

Bill Braun stated Brett Schultz is requesting another reduction which Mr. Braun has inspected and agrees. Longdon made a motion to reduce Sonoma Valley's letter of credit by \$60,967.04 for a revised amount \$449,254.80. Kroll, seconded. Roll call, yes.

Mr. Braun stated the road weight studies are complete and suggests having the solicitor review the requirements, notify the enforcement agencies and prepare a resolution to adopt the weight limits on all the roads. The board asked Mr. Menchyk, Jr. to take care of.

Secondly, Mr. Braun said a draft letter will be submitted to the DEP by the end of June related to our Act 537 plan.

Discussed Rt. 68 turning lane funding and status. Mr. Menchyk, Jr. stated Honda North will be contributing. Steinheiser noted money needs to be received by August. Mr. Braun mentioned he will be sending a drainage and right-of-way plan to PennDot by July. Mr. Braun also said Trans Associates will complete a ARLE grant application for \$500.00 for timing of signals (automated) to help the congestion at Brandywine, Eagle Mill, Whitestown and Benbrook Rds. Steinheiser motioned to hire Trans Associates to complete application process for \$500.00. Kroll seconded. Roll call, yes.
