Lee Kradel stated the Act 13 Impact Fee fund balance also remained the same at \$165,527.01 but with the CD in the amount of \$500,000, the total is \$665,527.01. Ray Gusty representing #1 Cochran was present asking the board the status of the Sewage Planning Module. Mr. Menchyk, Jr. told Mr. Gusty that he needs specifics on how the system is going to operate and be maintained so they can be incorporated into the agreement. Mr. Gusty felt the Sewage Planning Module could be submitted to DEP now and then the agreements could be worked out. Brenda Davis said the way she understands it is the Resolution and the agreement with the Township needs completed and inserted in the Sewage Planning Module before it goes to DEP and feels this is the hold up. Mr. Menchyk, Jr. suggested putting the Resolution on the February supervisors meeting and also work on getting the agreement in place. Bill Braun asked Mr. Gusty to re-send him a complete copy of the Sewage Planning Module so he can review and assist in getting this resolved. Mr. Gusty provided a checklist to summarize what has occurred since the March 9, 2017 Planning Meeting and what is still needed. Steinheiser told Mr. Gusty that Brenda will give a copy to the board, solicitor and engineer to assist in getting this resolved.

Mr. Braun said he will have further discussions with them. Kroll asked if Brandywine system could be used to cover the needed areas? Mr. Braun said that using Brandywine system could become very expensive over time and doesn't feel this would be the answer. Steinheiser closed the discussion by asking Mr. Braun to get back to studying all the alternatives and bring his suggestions to the supervisors.
