Brenda Davis stated the Act 13 Impact Fee beginning fund balance was \$242,613.13 but with \$41.21 interest, the balance is \$242,654.34 and the CD remained the same at \$729,392.97 leaving a total of \$972,047.31 in the Act 13 account. Brenda Davis stated the American Relief Plan had a beginning balance of \$203,305.47 but with interest in the amount of \$34.53 the ending balance is \$203,340.00.
