Kradel motioned to set Treasurer's bond at \$750,000 for both the Treasurer and Asst. Treasurer. Spangler seconded. Roll call, yes.

Spangler motioned to appoint Kradel as roadmaster with his pay to be set by the elected auditors. Steinheiser seconded. Roll call, Steinheiser, yes. Spangler, yes. Kradel, abstained.

Steinheiser motioned to reappoint Andrew Menchyk, Jr. with the firm "Stepanian & Menchyk, LLP" as solicitor according to his 2023 rate sheet. Kradel seconded. Roll call, yes.

Steinheiser motioned to reappoint Bill Braun from Senate Engineering as the Township's engineer according to his 2023 rate sheet. Spangler seconded. Roll call, yes.

Steinheiser motioned to reappoint Lee Kradel as the BCATO representative. Spangler seconded. Roll call, Steinheiser, yes. Spangler, yes. Kradel, abstained.

Steinheiser motioned to appoint MaherDuesel as auditors for 2023 to audit the 2022 books. Kradel seconded. Roll call, yes.

Steinheiser stated the road workers wage is set by the union contract.

Steinheiser motioned to set the monthly supervisor meetings for the first Wednesday of each month at 6:00 p.m. at the Township Building, seconded by Spangler. Roll call, yes.

Kradel motioned to set the Planning Commission meetings for the third Wednesday of each month at 6:00 p.m. at the Township Building and the pay rate remains at \$50/mo. Kradel seconded. Roll call, yes. Steinheiser questioned increasing their pay per meeting. Mr. Menchyk, Jr. stated he would have to look at the Municipal Planning Code to determine if it is permissible. Steinheiser tabled the discussion. Steinheiser mentioned holidays for the road workers are set by the union contract and motioned the Secretary/Asst. Treasurer and Treasurer/Asst. Secretary will follow the same. Kradel seconded. Roll call, yes.

Steinheiser motioned the road workers personal days are set by the union contract. Steinheiser motioned the Secretary/Asst. Treasurer and Treasurer/Asst. Secretary receive 5 paid personal days per year. Spangler, seconded. Roll call, Steinheiser yes, Spangler yes, Kradel abstained.

Steinheiser motioned the road workers sick days are set by the union contract. Steinheiser motioned the Secretary/Asst. Treasurer and Treasurer/Asst. Secretary receive 4 paid sick days per year. Spangler, seconded. Roll call, Steinheiser yes, Spangler yes, Kradel abstained.

Steinheiser adjourned the meeting at 6:20 p.m.to the supervisors meeting. Kradel seconded. Roll call, yes.
